28th Annual Jemez Red Rocks Arts and Crafts Show 2018 MEMORIAL DAY WEEKEND

RULES- Please keep this page for reference

- 1) The show is limited to members of federally recognized Native American Tribes in accordance with the [Indian Arts and Crafts Act](#). **Artists must be able to provide a copy of your CIB.**
- 2) **Acceptable Art:** Artists are to sell only fine artwork they have created. "Fine artwork" is defined as art forms that include jewelry, pottery, textiles, painting, sculpture, woodcarvings, photography, mixed media and other visual arts.
- 3) Show hours: 9:00 a.m. to 5:00 p.m. Memorial Day Weekend- Saturday, Sunday, and Monday. Set up will start taking place Friday the day before the show. Set up will start at 7:00 a.m. Artists must be ready for business by 9:00 a.m.
- 4) **BOOTH/ARTIST FEES:** Booth space will be 10feet x 10feet. Booth spaces will be marked. **Artists must provide your own canopy, tables and chairs.** Booth spaces will be assigned on a first-come, first-serve basis. All Booth fees must be paid by April 30th.
 - a. **Early-bird Price:** \$125.00 DEADLINE- March 31st
 - b. **Regular Price:** \$150.00 DEADLINE- April 30th
 - c. **Late fee:** \$50.00 + Regular price, DEADLINE- May 13th
 - d. **Additional Artist Fee:** \$50 for additional artist in booth, limit of 2 per booth.
- 5) **ARTIST MUST BE PRESENT:** All works displayed must be made by the artist, or artists, occupying the booth. No dealers or traders will be allowed. Please sign all your work with your signature or trademark.
- 6) The Jemez Red Rocks Arts and Crafts Show does not allow the exhibit or sale of sacred ceremonial artifacts or items made from or made with protected animal species ([The Bald and Golden Eagle Protection Act](#), [Migratory Bird Treaty Act](#)).
- 7) No food vending will be allowed in the Artists booths. Food items including: cookies, pies, pinons, blue corn meal, piki, blue or white corn, homemade candy, etc. No soliciting will be allowed.
- 8) Please be professional towards other artists and visitors. Any disputes or conflicts may result in being asked to leave.
- 9) **LIABILITY:** While participating in the show, the vendor understands and agrees that the Pueblo of Jemez and Jemez Arts and Crafts Association will not be liable for any loss, damages, theft of property or any bodily harm arising directly or indirectly from their participation in the Jemez Red Rocks Arts and Crafts Show.
- 10) Monitors will be present to enforce these rules and regulations. If you are found violating any of these rules and regulations, you will be asked to leave. Let's all work together to avoid this from happening.
- 11) **THERE WILL BE NO BOOTH REFUNDS AND BOOTHS ARE NON-TRANSFERABLE.**
